Equal Protection from Assault for All Children in UK

The Children's Commissioner has published a statement calling for an end to the physical punishment of children in England and Northern Ireland, stating that every child in the UK should have the same legal protection from assault as adults. The Commissioner for England has called for an amendment to be introduced to the Children's Wellbeing and Schools Bill to remove the defence of 'reasonable punishment' in the Children Act 2004. Ofsted have announced changes to how children's social care providers in England will be inspected to encourage more children's homes and agencies to look after children who have complex needs. The effectiveness of providers' work with partners to achieve greater stability for children, especially for those at most risk of instability, will be central to future inspections.
