



Violence Against Women and Girls

The UK government has published its strategy addressing violence against women and girls, which outlines the work the government has committed to undertaking based on three areas: prevention and early intervention; working to improve justice outcomes; and support for those affected by violence and abuse. Children, Violence & Vulnerability Research

The Youth Endowment Fund (YEF) has published the final findings from its annual Children, Violence & Vulnerability research, where they surveyed 11,000 13-17 year-olds about their experiences of violence. Findings include: 1 in 8 teenagers were asked to sell, transport, or store drugs, weapons or money; criminally exploited teenagers were 18 times more likely to face serious violence; and adverse home environments were associated with increased risk. Proposed Child Protection Authority Public Consultation

The DfE has launched a consultation (closing 5th March) on the creation of a new national body to improve child protection in England. The Child Protection Authority (CPA) will aim to provide national leadership and oversight, use data and intelligence to spot risks early, and advise on policy at local and national level. Responses are invited from children and families, frontline practitioners, local authorities, and VCS organisations involved in safeguarding. Youth Matter: Your National Youth Strategy

The Department for Culture, Media and Sport (DCMS) have co-produced a national youth strategy with over 14,000 young people taking part. The work will include: ensuring young people have access to trusted adults; helping them develop positive social connections in schools, colleges, communities and online; involving them in decisions that affect them. Cyberbullying and Mental Health

King's College London has published [new research](#) examining links between cyberbullying and mental health conditions in adolescents in the UK. Findings show that adolescents who have experienced cyberbullying are more likely to have mental health conditions by age 18; however, it is highlighted that cyberbullying usually occurs alongside other offline harms which are also likely to contribute. Researchers are calling for policy-makers to look beyond online harm when considering how to protect young people.

Child Sexual Abuse & Exploitation

The DfE has published new data on children in England who have been recorded as being affected by CSA or CSE. Key findings show: 29,560 children assessed as having been affected by CSA; 12,120 children assessed as having been affected by CSE; girls were over-represented in the assessments; children affected by CSE having one of the highest re-referral rates while those affected by CSA had one of the lowest re-referral rates. Child Poverty Strategy

The UK government has announced the launch of a new strategy for reducing child poverty. The strategy brings together information about the action that the government has already taken, alongside new measures to increase family incomes, reduce essential costs and strengthen local services to try to address the root causes of child poverty and provide immediate support to families living in poverty.
